## ABOUT THE EVENT

#### Background

Addressing gender-based violence has been an ongoing commitment of the European Union (EU). Currently, the European Commission 'Gender Equality Strategy 2020-2025' identifies that 'gender-based violence, in all its forms, remains under-reported and overlooked, both inside and outside the EU. The EU will do all it can to prevent and combat gender-based violence, support and protect victims of such crimes, and hold perpetrators accountable for their abusive behaviour'.

The Scientific Analysis and Advice on Gender Equality in the EU (SAAGE) network is funded by the European Commission to support EU level policy initiatives by providing expertise and knowledge in the field of gender equality, and is coordinated by Fondazione Giacomo Brodolini, an independent research centre.

As part of its commitment to addressing gender-based violence, the European Commission sought a study from the SAAGE network to inform the European Commission on the issue of obstetric violence in the EU Member States and contribute to a better understanding of this phenomenon. This study, 'Obstetric Violence in the European Union: Situational analysis and policy recommendations', was authored by Dr. Patrizia Quattrocchi and completed in 2023.

This study was further informed by four detailed cases undertaken in the third quarter of 2022 by national experts in France (Virginie Rozée and Clémence Schantz), the Netherlands (Rodante van der Waal and Marit van der Pijl), Slovakia (Barbora Holubova) and Spain (Stella Villarmea and Adela Recio Alcaide) to further inform the study and its recommendations.

The four Member States were selected for their diversity of geographical location, social and cultural context, obstetric practices and healthcare systems, and data availability. The case studies sought to: identify and understand the empirical evidence available on obstetric violence in these jurisdictions, manifestations and causes; identify initiatives in these jurisdictions, from government, institutions and associations, that have led to greater consideration and awareness of obstetric violence; and formulate recommendations to inform policy and practice.

#### Purpose

The seminar seeks to:

- Share and deepen knowledge about and understanding of the issue of obstetric violence and the policies and practices required for its elimination.
- Stimulate insights to inform any potential response from the European level.

#### Format

The seminar will be hybrid. The in-person event, will be hosted in Brussels.

#### Participants

The participants at this seminar will be European Commission staff, a number of the experts involved in this work, and European level stakeholders relevant to this issue.
